b) In Part C, add Condition C.7 as follows:

#### C.7 Controlled Activity Approval for underboring of Thredbo River

Any construction works/activity in, on or under waterfront land shall not commence until a Controlled Activity Approval is obtained from the Department of Primary Industries - Water and a copy of that approval has been provided to the Secretary or nominee. Waterfront land is that land that is in / within 40 metres of the high bank of the Thredbo River.

c) In Part D, add Condition D.20 as follows:

# D.20 Underboring

Approval is provided for underboring activities only. Where sub-surface rocks are encountered and works are ceased and unable to proceed by going deeper / around, the Department and OEH are to be consulted. Alternative alignments or removal of rocks require further approval from the Department.
