Re: S.4.55 (1A) Modification of DA 9373 for Additions and Alterations at 'Melaleuca 1', Diggins Terrace, Thredbo Alpine Resort

On behalf of the Applicant and Sub-lessee, Dabyne Planning Pty Ltd has been engaged to review the proposed modified development in context with the original approved development and Aboriginal Due Dilligence Assessment prepared in May 2018.

The original assessment determined that:

'A revised search of the lot has found no record of any Aboriginal sites or places.

The subject site is not located within a sand dune system, on a ridge top, ridge line or headland, located within 200m of a cliff face or within 20m of or in a cave, rock shelter or cave mouth.

The site is located within 100m of Thredbo River.

However the proposed development is located on highly disturbed land as defined, due to the previous construction of the chalet and adjacent development including drainage & infrastructure.

Therefore the original soils (and hence archaeological potential) have been removed, demonstrating a high level of disturbance'.

A review of the proposed modifications have determined that the revised design is located over highly disturbed land as defined. Therefore the original conclusion still stands:

'Therefore after completing steps 2a and 2b, it is reasonable to conclude that there are no known Aboriginal objects or a low probability of objects occurring in the area of the proposed activity, and the development can proceed with caution without applying for an AHIP. This fulfils all reasonable steps under the Due Diligence Code'.


