- (2) for a modification to the consent, within 3 months after the date on which the application received this notice.

**Applicant** means Perisher Blue Pty Ltd.

**Approval Body** has the same meaning as within Division 5 of Part 4 of the Act.

**BCA** means the edition of the Building Code of Australia in force at the time of lodgement of a construction certificate.

**Certifying Authority** has the same meaning as Part 4A of the Act.

**Department** means the Department of Planning and Infrastructure.

**Director** means the Director of the Metropolitan and Regional Projects South (or its successors) or a delegate of the Director of the Metropolitan and Regional Projects South within the Department.

**Director-General** means the Director-General of the Department.

**Minister** means the Minister for Planning and Infrastructure.

**DA 036-08-2011 MOD 1** means the modification application and supporting documentation submitted by the applicant on 13 February 2012.

**PCA** means the Principal Certifying Authority as prescribed in Part 4A of the Act.

**Regulations** means the *Environmental Planning and Assessment Regulations, 2000* (as amended).

**Subject Site** has the same meaning as the land identified in Part A of this schedule.

The development shall be in accordance with these above approved plans and documentation.

**(b) Condition B.5 is deleted and replaced with:**

**B.5 Geotechnical**

All works for the development shall comply with:

- (i) the Department's Geotechnical Policy;
- (ii) the Geotechnical Site Assessment undertaken by Coffey Geotechnics Pty Ltd for the proposal, dated 26 September 2011, Reference GEOTFYSH09460AA-01 (reference 2 in condition A1); and
- (iii) the Geotechnical advice provided by Jeffrey and Katauskas Pty Ltd dated 24 January 2012 (reference 7, condition A.1).

**(c) Condition B.7 is deleted and replaced with:**

**B.7 Tree trimming**

No trees shall be removed, trimmed, lopped or damaged except as marked by a yellow dash in the approved SEE and Supplementary Report (references 1 and 6, condition A.1).

**(d) Condition C.2 is deleted and replaced with:**

**C.2 Documentation for the construction certificate**

Prior to the issue of the construction certificate, the following information shall be submitted to, and be to the satisfaction of the certifying authority:

- (a) Structural drawings and design statement - prepared and signed by an appropriately qualified practising Structural Engineer that comply with:
  - (i) section B of the BCA;
  - (ii) development consent DA 036-08-2011;
  - (iii) drawings and specifications comprising the Construction Certificate;
  - (iv) the Geotechnical Site Assessment undertaken by Coffey Geotechnics Pty Ltd for the proposal, dated 26 September 2011, Reference GEOTFYSH09460AA-01 (reference 2 in condition A.1); and
  - (v) the Geotechnical advice provided by Jeffrey and Katauskas Pty Ltd dated 24 January 2012 (reference 7, condition A.1).
- (b) Compliance with the BCA - sufficient details to demonstrate that the proposal complies with the relevant provisions of the BCA.

**(e) The following condition is inserted below Condition D.6:**

**D.7 Site P13**

- (a) Prior to the commencement of any works at site P13, the rehabilitation plan (see condition D.1) shall be amended to incorporate offset plantings for the loss of trees at site P13.
- (b) The amended plan shall be submitted to and approved by the PCA. If the Department is not the PCA, a copy shall also be submitted to the Department.

**(f) The following condition is inserted below Condition E.15:**

**E.16 Site P13**

- (a) The sod-replacement technique shall be employed along the lateral trench at this location. This means sods are to be taken as the trench is excavated, stored while construction activities are occurring, and then replaced along this trench line to rehabilitate the site.
- (b) As far as possible within the construction corridor, the native vegetation surrounding the pit at this location shall be protected from being damaged.
